EXECUTIVE DIRECTOR UPDATE:

Rodney Smith, board president reported that Clark County passed a 5 Cent Tax Levy, Statute 67.990 for the Clark County Council on Aging to provide services to persons sixty years of age or older.

The work in the office was scheduled to be completed on Thursday with all The furniture back in place on Friday however, due to the 51/2 inches of rain we received last Wednesday night water came in at ground level in two spots. The office has been dried out and steps will be taken to correct the areas of leakage.

ma4 is going to apply for a marketplace navigator grant. The navigator program will help consumers understand new coverage options and provide unbiased information to consumers about health insurance, the new Health Insurance Marketplace, qualified health plans, and public programs including Medicaid and the Children's Health Insurance program.

LEGISLATIVE UPDATE: The House budget includes \$1,570,000 for meals. The Senate did include \$1,570,000 for meals in their appropriations but the Appropriation's Committee cut the funding out of the budget. The senate budget now goes to the floor for debate and discussion- if these funds are not put back into the Senate version of the budget then the House and Senate will have to form a committee to reconcile the differences in the two proposed budgets.

Governor Nixon has announced that he does not support the elimination of the Property Tax Credit for renters.

President Obama's Fiscal Year 2014 budget proposes to fund Older Americans Act Supportive Services and Nutrition Programs at FY 2012 levels.
