The Department of Health and Senior Services has asked the AA's to identify any areas in our PSA's where we are unable to provide homedelivered meals.

We conducted our 3<sup>rd</sup> SCAMBOREE on May 24<sup>th</sup>. We partnered with RSVP and Community Opportunities, Inc. again this year. We had speakers from the Police Department and the Missouri Senior Medicare Patrol. We also offered the free shredding of documents.

The 2016 NEMO Senior Health EXPO will be held on Saturday, October 15, 2016 from 10:00 a.m. to 2:00 pm. At the Inter-professional Education Building at A.T. Still University in Kirksville. With all of our new partner agencies the EXPO will be even bigger and better.

The NAPIS program is being moved to a new program called AGING IS. The move is expected to be completed sometime in July. There will be free training of AA staff and contractors.

Good news- the new dietary guidelines issued in January are less restrictive for the sodium level and fat requirement then our current requirements.

ma4 is asking each area agency on aging to build an effective advocacy team for the promotion of the growth and development initiative in FY 17. The team needs to have individuals who can laser focus on this single issue and who are capable of helping us build a unified message across the state.

By the end of July each AA has to send a draft needs list to ma4. The needs list has to highlight all unmet needs. The purpose is to provide a strong rationale for increased funding and provide assurance that we have an immediate plan for the funds generated by the senior growth initiative.

- LEGISLATIVE UPDATE: When the Older Americans Act was re-authorized the Hold Harmless provision which would have shifted funds from the smaller states to the larger states was not passed. In Congress the Senate Appropriations Committee has approved an FY17 funding bill that cuts two programs for older adults. It will eliminate all of the funding for the Medicare State Health Insurance Assistance Program (ship) and cut the Senior Community Service Employment Program (scsep) by \$34.4 million.
- SHL REPORT: Walt Bittle reported on SHL activities and that the NE delegation will meet after the board meeting to choose 2 proposals and 5 alternate proposals to submit to the SHL Board.
- **C.A.R.E. REPORT:** Sandy Jung, Director of the Lincoln County Council on Aging's reported on the activities at the senior center.
