EXECUTIVE DIRECTOR UPDATE:

The Kirksville Senior Living Campus, Inc. at the end of February and they donated their remaining funds of \$2,893.57 to our agency to be used for the annual Senior EXPO or other services for seniors. Twila Anderson made the motion to approve using the funds for the annual NEMO Senior EXPO. Seconded by Joyce Findley and carried by aye vote of all those listed above as present.

HHS is creating a new organization, the Administration for Community Living (ACL) with the goal of increasing access to community supports and full participation, while focusing attention and resources on the unique needs of older Americans and people with disabilities.

Bridget Morton, grant manager for our Increasing Access to Behavioral Health Services for Older Adults grant form the MO Foundation for Health will be presenting a session on the Healthy IDEAS component at the Aging Summit in August.

The Department of Insurance put out a bid for the CLAIM program and MA4 submitted a proposal.

There is a bill in the legislature that will change the laws regarding referrals for MO HealthNet funded home and community based care.

LEGISLATIVE UPDATE: The House budget that went to the Senate included the \$941,620 in additional funding for meals. Several bills to reauthorize the Older Americans Act have been introduced in the Senate.

NE region representative Twila Anderson; Mark Twain region senator Mary Lou Brennan and representatives George Wisdom, Wanda Smith and Genevieve Lynch were automatically re-elected as were all alternates- Duane Frey, Donnie Wagers, Elizabeth Reel, Travelle Whitaker and Bob Smith- there was no competition. In the Boonslick region there are 4 representative positions and 3 alternate positions vacant.
- 6. Budget Update The Governor recently released the rest of the \$941,620 withhold- \$ 470,000. Jim Boettcher made the motion to fully restore the funding cuts to contractor's allocations. Seconded by Wilma Stephens and carried by aye vote of all those listed above as present
- 7. Standing Committee Reports No board committee met in the 3rd quarter. The personnel committee met today approving revisions to the personnel policies. After discussion Jim Boettcher made the motion to approve the revisions. Seconded by Ruby Dunbar and carried by aye vote of all those listed above as present.
- 8. Disease Prevention Funding Funding requirements have changed and we are going to have to start contracting with an evidence-based disease prevention and health promotion program in FY 13
