EXECUTIVE DIRECTOR UPDATE. The 2nd annual NEMO SENIOR EXPO was held on October 26 at the Kirksville Rehoboth Baptist Church with about 50 venders and about 250 persons attending. We have \$996.44 left in the account to start next year.

As of October 31 we have submitted 31completed LIS and MSP applications for our MIPPA contract; our target is 44 applications for FY11. Help with plan comparisons is available from the area Agency/contractors.

Open enrollment for Medicare Part D started November 15 and runs until December 31.

In November the architect check the building addition and approved paying the contractor. The bid was \$59,500.00 and the actual cost was \$60,127.80. The cost Increased due to additional

worked being performed. The architects cost was \$1969.00 We have increased the insurance coverage on the building. We have \$36,000.00 of donated money remaining.

The four Alzheimer's Associations in Missouri received a grant to expand use of an AD-8 screening tool by AAA's to help identify clients who are experiencing cognitive impairment. AAA's will be reimbursed \$10.00 per screening- \$20,000 has been set aside in the grant for this purpose.
